The district will be reimbursed \$6,167 for a 50/50 grant. Would like to thank MS75 for raising over \$6000. for this grant. We will be applying for the 2016 50/50 grant. Tentatively planning an evacuation drill on June 4, 2016. We now have a new propane vendor. Water Tender committee has met with Georgetown Fire Department.
