#### Personnel:

Our current department roster is comprised of 39 active members, including 18 support group volunteers, of which 13 are in the medical cadré. Our 21 rostered firefighters include one chief/paramedic, one assistant chief, one division chief of Special Operations, one battalion chief, two part-time captain paramedics, and one lieutenant. Of our fire personnel, we have 15 members that can drive and operate all equipment.

## **My Interview**

Over the last few months there has been great contention regarding my position and promotion to fire chief. So, I felt it necessary to provide the residents of the Fire District with my background and experience. In an essence; to conduct an interview with the community.

## **Previous Experience and How I Came to the Mosquito Fire Protection District.**

In 1979, after completing high school early, I joined the California Department of Forestry, now CALFIRE, and served two years in the fledging Helitak program, assigned to Boggs Mountain. I also completed my EMT 1-A training.

Upon completion of my first season in September of 1979 (the fire seasons were considerably shorter), I entered a six-month paramedic training program at Stanford University. I completed my training in March 1980, passed the 9 Bay Area County Test (ABAG), and certified as a paramedic in April 1980. I was hired by the East Contra Costa Ambulance Service District in April 1980, then returned to CALFIRE in May of that year.

After several fire attack insertions during the fire season of 1980, I was hired by the then San Leandro Fire Department. San Leandro Fire was a plank in the development of the Alameda County Fire Department (ACFD).

I entered the Fire Academy in October of 1980, remaining until my retirement.

In July of 2012, after a long active career with ACFD working in one of the most dynamic emergency service systems in the state of California and a department recognized nationwide as an elite fire agency, I was diagnosed with cancer, with direct correlation to hazardous exposures from a lifetime of doing the job.

I underwent radiation, surgery and chemotherapy. I returned to the line in January 2013, not knowing the unseen damage caused by chemotherapy. In November of 2013, while working in extreme fire conditions advancing a 2-1/2" line under pressure to fight fire in a five-story center hallway apartment building with near 30 percent involvement of the 5<sup>th</sup> floor, I felt both my knees tear. What was unknown to me then was that over the months following my return to the job, the connective tissue in my knees had slowly disintegrated.

In June of 2015, following 36 years of service, and promoting through the ranks from recruit firefighter/paramedic to fire captain/paramedic, then to district captain in charge of 5 stations, I was retired from the ACFD due to complications related to my bout with cancer. During that time, I had responded to some of the most iconic emergencies in the State of California, across the country, and globally with FEMA/USAR Taskforce 4 out of Oakland.

Having passed the Battalion Chiefs Test multiple times over 15 years, choosing to work overtime and occasionally perform upper-rank duties, I truly never had any great desire to promote up from engine boss. I loved being a dirty shirt captain, riding the front right seat of the engine and enjoying the camaraderie of the kitchen table with my crew.

In August of 2016, I was recruited by then Mosquito 75 Chief Mike Hazelet, to assist him in rebuilding a fire district in decline. I was hired as the fire captain. In my first week, I was tasked with reviewing and providing a readiness report regarding the Fire District's ability to respond to emergencies. What I found was shocking. My report basically recommended shutting down operations of the Fire District. I then devised an operational plan to borrow fire engines and equipment from partner agencies to keep the doors open. We had to buy new turnouts and protective equipment for our members.

Two weeks following my report, Chief Hazelet resigned, recommending to the MFPD Board of Directors that I become fire chief. After two years of hard work, we were fully OSHA compliant, had a robust training program and were running near daily paramedic operations. At the time, the paramedic service we provided cost the community only \$7,500 annually. While things were far from perfect, they were considerably better.

During this time, our paramedic program had four cardiac saves with numerous other rescues. A cardiac save is the resuscitation of a patient whose heart and breathing has ceased. Our crew revived each community member, and all four recovered and returned home. Professional personnel, including strong EMT capable firefighters, an experienced firefighter paramedic, in conjunction with solid near immediate CPR, medication and electrical therapies created the environment for successful resuscitation.

In June of 2019, I had a reoccurrence of cancer and underwent intensive treatment, returning to work 45 days later. After my wife was diagnosed with breast cancer in late 2019, I separated from the Fire District in February of 2020. Following my separation from the MFPD, I assisted many other small rural fire districts in the development of special operations programs, including technical rescue, community paramedicine, HAZMAT, swift water teams.

In June of 2023, Chief Rosevear asked that I come back and assist with the recruitment and retention of volunteer personnel. We were able to bring on a tremendous workforce of well trained and skilled personnel, then also recruit back former members and two part-time paramedic captains to the Fire District. While serving with Chief Rosevear, a new fire was lit, with a desire to complete work left undone.

I had absolutely no intent on staying past Chief Rosevear's need for assistance, and no intent to ever return as fire chief. It was only when Chief Rosevear gave word that he was retiring, that I asked his blessing to seek the chief's position. It was his recommendation to the board that I succeed him. The Board chose to utilize district policy to promote from within. In January, I signed an 18-month contract, which at completion will not be renewed, as I have plans to retire from the fire service on August 1, 2026.

**What do I get from being hired?**

I have no need to build a resume, and I am not seeking to become fire chief of any other fire department. The MFPD is my career end. Primarily, what I get is the chance to complete work left undone from my first tenure, on behalf of this community. My goal is to develop Fire District special teams, which on deployment can both serve the Fire District and the Community of Mosquito and Swansboro, as well as draw in younger well trained personnel who will in the future take part as volunteers eligible to deploy seasonally. The special teams will earn new money for the Fire District while also reducing the impact of deploying fire apparatus. This also has the great potential of providing a near full year income to our members, with limited impact on our budget.

### **My Contract.**

My contract was written to reduce my fiscal impact on the district budget as much as possible. I chose not to accept medical or retirement benefits, saving the district nearly \$19,000 over the course of my 18-month commitment. All accumulated unused leave is considered use or lose on separation to prevent any unfunded liability.

### **So why do what I do?**

I am a professional firefighter. My career has spanned nearly 75% of my lifetime. My life is to be of service, never self-serving, to deliver the absolute best to the community for which I am employed. As I did in Alameda County, so now in Mosquito. There isn't a life in the Fire District that doesn't deserve the best emergency service that can be provided. We have made a difference.

My goal is to provide the best emergency service to this community, then leave a resilient Fire Department that is self-reliant and self-supporting, and no longer dependent on a single person.

### **Compensation:**

My compensation is \$82,000 annually, for a 24/7/365 job.

### **Comparable Compensation for Fire Personnel in El Dorado County.**

In El Dorado County, the position of fire chief pays in the range of \$180,000 to \$236,000. The average firefighter compensation package ranges from \$136,000 to \$198,000. This compensation does include benefits.

### **So why am I the best candidate, and what have I done to prepare myself for this position?**

Out of any candidate group, I believe I have the greatest knowledge regarding the service needs of this community. I understand the nuances necessary and the commitment this community requires.

The Mosquito Fire Protection District is a small rural special fire district located in the Sierra Foothills, on the western Slope of the Georgetown Divide. The district is an extreme technical wildland interface community requiring considerable tactical knowledge as it is bordered by the South Fork of the American River Canyon, BLM property to the south, the El Dorado National Forest to the north and east. The Fire District is situated on the ridge just above the South Fork of the American River with a 15 mile south facing aspect of considerable slope and contiguous fuel loads of 15 (USFS Fuel modeling) or heavier. The Community is located atop of a series of drainages, chimneys, draws with a prevailing upslope westerly wind pattern.

The location of the Fire District requires quarterly evaluation to carefully plan for changes regarding disaster management. These evaluations provide information for the development of

pre-emergency response matrices designed for changing fuel loads and weather events from extreme Fire Weather to heavy rain and snow, which affects the access to the community for external emergency resources.

These evaluations and preplans also identify access and egress, actions and resources required for pre incident mitigation needs required to protect homes and structures that would be in immediate threat during wildland fire incidents.

Due to the isolated location of this community, emergency medical services creates an extreme technical problem. Requiring constant evaluation of response routes, availability of external resources and partner agencies. In 2016, I was able to establish paramedic services on a consistent daily operation. Planning and budgeting had allowed the Fire District to provide and maintain Advanced Life Support Services, which was long denied to this community. The pre-planning for the Fire District also established safe refuge areas, and evacuation routes for community residents, identifying when and how air assets are utilized for EMS Transport. As chief, I was responsible for the all-facets management of a 68-member agency which included a 30-person Community Emergency Response Team (CERT), and 38 active paid and volunteer firefighters. I was the primary liaison establishing combined services agreements including working relationships with internal and external county, state and federal fire agencies and county fire safe councils.

Reports written, identifying compliance with local, state and federal laws and regulations. Worked with NHTSA Office of EMS, safety regulatory bodies such as FEDOSH, CALOSH, NFPA, ANSI and FEMA, to establish policy consistent with local, State and Federal laws and regulations.
