RESOLUTION NO. 2023-02

WHEREAS, the Board of Directors conducted a hearing on the appropriation limitation for Mosquito Fire Protection District on, Thursday June 22^{th} , 2023; and,

WHEREAS, the hearing was advertised and noticed as required by law; and,

WHEREAS, the Board received testimony and other evidence regarding the appropriation limitation to be established for the Mosquito Fire Protection District.

NOW, THEREFORE, IT IS HEREBY RESOLVED by the Board of Directors of Mosquito Fire Protection District that the appropriation limit for the 2023-2024 fiscal year, as described in Article XIII B of the State Constitution and implemented by Chapter 1205, Statutes of 1980 is the sum of \$ 350,185.44 computed as follows, \$ 350,185.44 (2022-23 Approp. Limit) (X) 1.0404 = \$ 364,332.93 (2023-24 Approp. Limit)
